Application, Drawings, & Deadlines

- All Applications (for all species and all applicants) deadline will be May 31, 2024. Any applications that are received after this date will not be eligible for drawing. All application fees must be paid before 4:00pm to the Finance Department. Any application fees not paid by May 31, 2024, will be ineligible for drawings.
- ALL DRAWINGS will be held on June 19, 2024. Results will be posted June 26, 2024, at the Fish & Wildlife office and at http://www.ashiwi.org/FishandWildlife.html (ZFWD Webpage). Draw date and draw results dates are subject to change without notice.
- All Successfully drawn applicants must submit full payment for drawn hunt before 4:00PM on August 2, 2024. Unpaid permits after this date will be forfeited and offered to alternates or will be re-advertised and available on a first come first serve basis.
- Drawn Applicants will be given until August 2, 2024, to submit payment for permit. Any permits not paid for before 4:00PM on August 2, 2024, will be offered to alternates. Alternates will be given 5 working days to purchase the permit.
- Non-Zuni Resident, Non-Zuni Spouses, and Other Native Americans are still required to fill out a single hunt application.
- One (1) application per hunt, per hunter may be submitted with a nonrefundable application fee of \$20.00.
- **Non-Zuni Resident** Individuals who reside within the Zuni community (with proof of one (1) year residency), OR individuals who are employed within the Zuni community (with proof of one (1) year current employment) but do not reside within the Zuni community.
- Hunts # 1-NZ, 4-NZ, and 5-NZ will now be granted access to hunt the Tribal sections of Mazone Ranch and the Main Zuni Reservation. Hunters will still need to be accompanied by a tribal certified guide or tribal member and still abide by all rules and regulations.
