As stated in the 2021 Big Game Proclamation “It is mandatory that hunters complete and submit hunter survey questionnaire. Surveys must be returned 15 working days after completion of hunt to the Zuni Fish and Wildlife Department. Individual who failed to submit the survey (within the 15 days) can pay a **\$20 late fee and submit survey to be allowed to apply for 2022 Big Game Hunts**.
