# Zuni Tribal Fishing, Waterfowl, & Small Game Proclamation



Approved: September 20, 2022

# **General Information**

Important information you need to know before applying for any hunting and fishing activities on the Zuni Reservation. All game, fish, wildlife, natural resources, shed antler(s), skulls with antlers, all archeological artifacts and sites are protected on the Pueblo of Zuni by Tribal and Federal Law and may not be taken, possessed or transported by Non-Zuni Tribal members without proper permitting and documentation.

The sole purpose of this document is to provide written documentation for the Tribal Small Game, Waterfowl Hunting, & Fishing activities provided by the Zuni Fish and Wildlife Department (ZFWD) on an annual basis. Upon the Tribal Councils approval, this document will govern the activities of Tribal, Non-Zuni Residents, and Non-Zuni Spouse hunting and fishing activities administered through the Zuni Fish and Wildlife Department.

The license year of the Zuni Fish and Wildlife Fishing, Waterfowl, & Small Game Proclamation will begin September 1, 2022 and will end August 31, 2023.

By the Fishing, Small Game, and Waterfowl Hunting Proclamation that has been set forth and approved by the Tribal Council, only the Zuni Fish and Wildlife Department (ZFWD) and its recognized vendors may issue small game hunting & fishing permits.

**The Zuni Fish & Wildlife Department** offers a variety of hunting and fishing opportunities. Hunting permits for Zuni Tribal members, Non-Zuni Residents, and Non-Zuni Spouses are available for dove, waterfowl, small game, and coyotes. A Zuni Habitat Stamp is required for all hunting, fishing, and trapping activities. The sale of the habitat stamps will fund habitat improvement projects throughout the Zuni Reservation.

**The Zuni Indian Reservation** is Tribal Land and is not open to unauthorized public use. All visitors are expected to abide by all Zuni Fish & Wildlife and Game & Fish Department and other Tribal Regulations.

All applicants are responsible for reading and understanding the Proclamation Rules and Regulations before applying. The Proclamation Rules and Regulations, permit numbers, and permit costs are approved through end of 2022-2023 season.

# **Important Reminders**

- It is a violation of tribal and federal law to disturb archeological sites or remove any artifacts, including potshards. Violators will be prosecuted to the fullest extent of all applicable laws/penalties.
- Zuni Bluehead Sucker fish, Chiricahua Leopard Frog, Mexican Spotted Owl, Southwestern Willow Flycatcher, Zuni Fleabane, and Mexican Grey Wolf are threatened or endangered species categorizing them as protected.
- Hiking, biking, and the use of any motor vehicle (ATV, UTV) on any established trials, BIA routes, & off-roading by the General Public is restricted on the Zuni Reservation. Walking/running by General Public is restricted established road and trails recognized by the Zuni Youth Enrichment Program (ZYEP). Pet owners must keep dogs on appropriate restraints (leashes/harnesses) at all times.
- The use of All-Terrain and Utility Terrain Vehicles (ATV/UTV) are allowed only on established road(s). ATV/UTV's may only be driven off established roads to retrieve big game animals.
- Non-Zuni Residents/Spouses and the General Public may visit the <u>Zuni Visitors</u>
  <u>Center/Mainstreet</u> for any archeological site tours and all other tours. **Zuni Tribal community** is encouraged to reach out to Zuni Visitors Center/Mainstreet for archeological site visits. - Non-Zuni Residents & Spouses: Eligible to fish and hunt on the Zuni Reservation with proof of information requested below. Please keep all pets on appropriate restraints at all times.
  - Non-Zuni Residents: Individuals who reside within the Zuni community (with proof of one (1) year residency), OR individuals who are employed within the Zuni community (with proof of one (1) year current employment) but do not reside within the Zuni community.
  - Non-Zuni Spouses: must provide legal marriage documentation in order to apply for and participate in any hunt.
  - Hiking, walking/running, and biking by Non-Zuni Residents/Spouses is restricted to established roads and trails recognized by the Zuni Youth Enrichment Program (ZYEP). For more information please visit <a href="https://www.zyep.org/">https://www.zyep.org/</a> or call <a href="footnote-start

# **Important Fishing Reminders**

- Do not clean birds & fish at windmills, stock tanks, and lakes.
- Do not litter or improperly dispose of dove/waterfowl/small game/fish parts.
- Do not leave fire(s) unattended or improperly handle fire. Please be aware of fire ordinances that may be in effect.
- Beware of livestock.
- Close All Gates.
- FREE FISHING DAYS
  - ❖ June 5 New Mexico Free Fishing Day. No License Required (All fishing rules and regulations apply). Limited to Zuni Tribal members, Non-Zuni Residents & Spouses.
  - September 25 National Hunting and Fishing Day. No license required (All fishing rules and regulations apply). Limited to Zuni Tribal members, Non-Zuni Residents & Spouses.

# **General Fishing Information**

# **License Information**

- 1. **Zuni Fishing Licenses** are nontransferable and nonrefundable if they are lost, stolen, or neglected in anyway.
- 2. **Zuni Fishing Licenses** are only valid on the Zuni Reservation. Licenses are not valid on any other tribal land(s), the State of New Mexico, or any other state.
- 3. **All Anglers** must have a current daily or season license along with a current Habitat Stamp when fishing.
- 4. **All Youth (Zuni & Non-Zuni Residents)** under the age of 12 do not have to possess a Zuni Fishing permit or a Habitat Stamp.
- 5. A Fishing License is required for all Adult & Juvenile anglers (Zuni & Non-Zuni Residents & Spouses) along with a Habitat Stamp when fishing on any lake on the Zuni Reservation.
- 6. **Second Rod Validation**, anglers 13 years of age or older must purchase a Second Rod Validation. Second Rod Validation not required with any free fishing licenses. Fishing with 3 or more rods at any time is not allowed.
- 7. Senior Citizens (65 and over), Handicapped/Disabled/Active Military & Veteran's permit: These persons receive a 50% discount on all permits, except Big Game Hunting and the Habitat Stamps. Must show proof of disability & handicap from a physician or Division of Motor Vehicle designation. Must show proof of Active military status and veteran status (DD-214).

# **General Regulations**

### It is unlawful to:

- Fish without possessing the appropriate license.
- Pollute streams, lakes, banks, and other water bodies.
- Fish without possessing a fishing license if 13 years of age or older.
- Use a license that has been issued to another individual.
- To fish with more than one rod without a valid Second Rod Validation License.
- Stock/release any live fish or fish eggs into any water on the Zuni Reservation (except fish caught legally in the same waterbody).
- Possess game fish without a valid license providing proof fish were taken legally.
- Take game fish by netting, seine, trap, grappling or other means not permitted by regulations.
- Fail to return and release all threaten and endangered gamefish species in appropriate habitat waters.
- Use mechanical or electrical devices capable of catching or killing game fish, except as permitted by regulation.
- For any person to litter Zuni lands with any type of household or yard waste anywhere on the Zuni Reservation.
- Exceed the daily bag limit or have more than the legal possession limit of any species.
- Have any alcoholic beverages or illegal drugs while hunting, fishing, or trapping on the Zuni lands.
   Anyone in possession or under the influence of alcohol/drugs will be reported to the appropriate authorities and permits will be immediately suspended with NO Refund.
- Shine spotlights or other artificial lights into areas with or without the possession of any sporting arm or fishing rod.
- Leave fire unattended or improperly handle fire. Please be aware of fire ordinances that may be in effect.

Tribal & Non-Tribal Members found in violation of the Pueblo of Zuni Law will be prosecuted in the Pueblo of Zuni Tribal Courts. The Zuni Fish & Wildlife Department has the right to refuse the sale or issuance of any hunting, fishing, or tapping permits to anyone.

# Fishing Rules & Regulations

- The Pueblo of Zuni has the right to refuse the sale or issuance of fishing permits to anyone.
- All anglers must/shall obey all Tribal, state, federal laws and rules and regulations.
- Camping is permitted at all tribal lakes and other designated camp sites as long as one member of the party has a valid Zuni big/small game hunting or fishing license.
- Camping will not be allowed when Fire Restriction Ordinances are in place.
- The ZFWD have adopted rules to address the issues spreading unwanted fish and invasive species on the Zuni Reservation.
- It is illegal to release live fish into any body of water on the Zuni Reservation without the proper documentation from ZFWD & Tribal Rangers.
- All Pet owners must keep dogs on appropriate restraints (leashes/harnesses) at all times.

# **Tribal Lakes**

Please call the ZFWD to check the status and the conditions of the lakes listed below.

- Ojo Caliente Cool water fishery. 15 miles southwest of the Zuni Pueblo. At full capacity, the lake ranges from 60-61 surface acres. The lake is spring-fed and recharged by seasonal runoff; therefore, water levels fluctuate year to year. Rainbow Trout and Channel Catfish are stocked annually to support a put-grow and take fishery.
- 2. <u>Eustace Lake</u> Cool water Fishery. The lake is 1.8 miles east of the Main Zuni Pueblo. At full capacity, the lake is 32 surface acres. The lake is spring fed and recharged by seasonal runoff and groundwater discharge seeps, and baseflows into the Zuni River. Therefore, water levels fluctuate year to year. Rainbow Trout and Channel Catfish are stocked annually to support a put-grow and take fishery.
- 3. Nutria #4 Cool water fishery. The lake is 14 miles northeast of the Zuni Pueblo. At full capacity, the lake is 88 surface acres. The lake is recharged by seasonal runoff from Rio Nutria. Therefore, the water levels fluctuate year to year. Rainbow trout and Channel Catfish are stocked annually to support a put-grow and take fishery when conditions are favorable.
- 4. Nutria #2 Cool water fishery. The lake is 11 miles northeast of Zuni Pueblo. At full capacity, the lake is 418 surface acres. The lake is recharged by seasonal runoff from Rio Nutria. Therefore, water levels fluctuate year to year. Rainbow Trout and Channel Catfish are stocked annually to support put and take fishery when conditions are favorable.
- 5. <u>Blackrock reservoir</u> Cool water fishery. The lake is located 4 miles northeast of Zuni Pueblo. At full capacity, the lake is 436 surface acres. The lake is recharged by seasonal runoff from the Zuni River; therefor water levels fluctuate year to year. Rainbow trout and Channel catfish are stocked annually to support a put and take fishery when conditions are favorable.
- 6. <u>Pescado Reservoir</u> Cool, warm water fishery. The lake is located 15 miles east of Zuni Pueblo. At full capacity, the lake is 120 surface acres. The lake is recharged by seasonal runoff from Cebolla Creek; therefor water levels fluctuate year to year. Rainbow trout and Channel catfish are stocked annually to support a put and take fishery when conditions are favorable.
- 7. <u>Galestina A & B</u> Cold water Fishery. The lakes are located 11 miles southeast of Zuni Pueblo. At full capacity, both lakes combine for a 11.2 surface acre. The lake is recharged by seasonal runoff; therefor water levels fluctuate year to year. Rainbow trout are stocked annually to support both putgrow and/or put and take fishery when conditions are favorable.

# **Boating Rules & Regulations**

- The use of a gas-powered motor on any Zuni Lake is prohibited unless authorized by the Zuni Fish & Wildlife Department.
- Only battery powered trolling motors are allowed on Zuni Lakes.
- All persons in canoe, kayaks, or rafts must wear a personal floatation device while the vessel is underway.
- Children 12 years and younger, must wear a personal flotation device at all times.
- Each vessel must carry a life jacket in good condition for each person on board and oars/paddle.
- Boating while under the influence of drugs or alcohol is prohibited.
- Clean, drain, and dry your boat and gear to stop aquatic invasive species.

# **Aquatic Invasive Species**

Aquatic Invasive species (AIS) are any nonnative plants, animals, or pathogens that can harm our aquatic bodies, environment, and the economy. The Zuni Fish & Wildlife Department works with the U.S Fish & Wildlife Service (USFWS) and the Southwest Tribal Fisheries Commission to help stop the spread of AIS.

### **How You Can Help:**

- Remove mud and aquatic plants from boats, trailers, gear including: waders, wader boots, life jackets, oar/paddle, etc.
- Pull drain plugs and empty live wells.
- Air and sun-dry boat compartments & equipment.
- Transfer of live fish from one waterbody to another is unlawful.
- AIS threats posed in New Mexico:
  - New Zealand Mud Snails
  - Zebra Mussels moss balls sold in pet stores were recently discovered to contain invasive Zebra mussels. # **Important Waterfowl & Small Game Reminders**

- Migratory Game Bird Species Include: White-winged and mourning doves, band-tailed pigeon, American coot, moorhen, snipe, ducks, geese, Sandhill crane, sora and Virginia rail. Hunting swans in New Mexico is not allowed.
- **Small Game** is recognized as prairie dogs, rabbits (cottontails & jackrabbits), ground & upland squirrels, skunks, porcupines, and coyote.
- Migratory Waterfowl and Dove: Seasons are set in the fall and generally coincide with NM State Game & Fish seasons for the Pacific Flyway, though bag limits may differ. Check with Zuni Fish & Wildlife Department in August for season dates and restrictions.
- Coyote: Season dates are set in the fall and generally coincide with NM State Game & Fish Furbearer
- Follow all season opening and closing dates for all hunting activities.
- Hunting is prohibited (Not Allowed) at the constructed wetlands, waste water lagoons (sewer ponds), and Black Rock Lake Bed.
- Do not clean birds & fish at windmills, stock tanks, and lakes.
- Do not litter or improperly dispose of dove/waterfowl/small game/fish parts.
- Beware of livestock.
- Close All Gates.

# Migratory, Upland, & Small Game Information

# **License Information**

- 1. **Zuni Waterfowl and Small Game Hunting License** are nontransferable and nonrefundable if they are lost, stolen, or neglected in anyway.
- 2. **Zuni Waterfowl and Small Game Hunting Licenses** are only valid on the Zuni Reservation. Licenses are not valid on any other tribal land(s), the State of New Mexico, or any other state.
- 3. Only Zuni Tribal Small Game, Dove, & Waterfowl Permits are valid for hunting on the Zuni Reservation. State dove & waterfowl licenses are not valid on the Zuni Reservation.
- 4. **All Waterfowl and Small Game Hunters** must have a current Zuni license for the season along with a current Habitat Stamp when hunting.
- 5. **Individuals 18 years of age or younger**, on the opening day of the season, must possess a Hunter Education Card or a Mentor-Youth Hunter Card from the state of New Mexico or from another state.
- 6. **Non-Zuni Waterfowl Hunters** must purchase a Federal Duck Stamp, which can be purchased at any Post Office or online: www.wildlife.state.nm.us or www.duckstamp.com.
- 7. **Report all banded birds:** NMDGF requests all banded birds harvested be reported online: <a href="https://www.reportband.gov">www.reportband.gov</a>.

# **General Regulations**

### It is unlawful to:

- Hunt any species outside of established season(s).
- For any person to litter Zuni lands with any type of household or yard waste anywhere on the Zuni Reservation except at the Zuni Tribal Transfer Station.
- Exceed the daily bag limit or have more than the legal possession limit of any species.
- Possess game birds, upland game, and small game without proper license.
- Shoot protected waterfowl species from within a motor driven vehicle, motor-driven boat, sailboat, or aircraft. **However**, an individual may shoot from a motor-driven boat when the motor is completely shut off and the motion or progress of the boat has completely ceased.
- Bait (placement of feed such as corn, wheat, salt, etc.) for the purpose of inducing or attempting to take any migratory game bird.
- Possess any alcoholic beverages or illegal drugs while hunting on the Zuni lands. Anyone in possession or under the influence of alcohol/drugs will be reported to the appropriate authorities and permits will be immediately suspended with NO Refund.
- Shine spotlights or other artificial lights into areas with or without the possession of any sporting arm.
- To shoot game on/from/across any graded or maintained road or within the right of way.
- To take or attempt to take any game for another person or to use another person's permit.
- To shoot at, pursue, harass, or drive out any game by the use of a motor driven vehicle or aircraft.
- To collect shed antlers and skulls or possessing cut-off antlers from skulls by the General Public.

Tribal & Non-Tribal Members found in violation of the Pueblo of Zuni Law will be tried in the Pueblo of Zuni Tribal Courts. The Zuni Fish & Wildlife Department has the right to refuse the sale or issuance of hunting, fishing, and trapping permits to anyone.

# **Waterfowl & Small Game Hunting Regulations**

- The Pueblo of Zuni has the right to refuse the sale or issuance of hunting permits to anyone.
- All hunters, trappers, and anglers must/shall obey all applicable Tribal, state, federal laws and rules and regulations.
- All hunters under the age of 18 years of age or younger must have successfully completed a Hunter Safety Program. Proof of hunter education certification (CIN #) must be in your possession while out in the field hunting.

- Legal Shooting Hours for Big & Small Game, Dove, Waterfowl, and Trapping are from ½ hour before sunrise to ½ hour after sunset.
- Camping is permitted at all tribal lakes and other designated camp sites as long as one member of the party has a valid Zuni big/small game hunting or fishing license.
- All recognized Upland Game may be taken with shotguns, muzzle-loading shotguns firing shot and bows. Squirrels may be taken with shotguns firing shot, muzzle-loading shotguns, rim-fire and muzzle-loading firearms, bows, and compressed air gun firing pellet.
- All recognized Migratory Game Birds may be taken with shotgun firing from the shoulder that is no
  larger than 10-gauge. Migratory game birds may also be taken with muzzle-loading shotguns firing
  shot, bow and arrows.
- **Proof of species, sex, and bag limit:** One foot of each quail and one fully feathered wing of each migratory game bird or Eurasian collard-dove must remain attached to the bird until it is at a residence, taxidermist, meat processing facility or place of final cold storage.
- Nontoxic Shot Waterfowl hunters must use and only possess non-toxic shot.
  - ❖ Nontoxic Shot: bismuth-tin, iron (steel), copper-clad iron, iron-tungsten, iron-tungsten-nickel, tungsten-bronze, tungsten-iron-copper-nickel, tungsten matrix, tungsten polymer, tungstentin-iron, tungsten-tin-nickel and tungsten-iron-polymer.
  - Nontoxic Shot: is not required for any species of upland game, dove, and small game.

### **PENALTIES**

Violation of any provision of this Code or any regulation or proclamation issued there under by the Tribal council shall, unless otherwise designated, be a class B offense and may in addition to any other prescribe penalties, be punishable by revocation of fishing, hunting, trapping licenses, confiscation and forfeiture of all equipment. The provisions for penalties herein shall apply to all persons, both members and non-members of the Tribe alike, unless otherwise provided herein. At the time an arrest is made and/or citation issued for violation of this code, the arresting officer may confiscate any fishing equipment, rifles, weapons or other fishing or hunting equipment or paraphernalia as reasonably appears to have been involved in the commission of the violation for which the arrest was made and shall give the person from whom such things are taken an itemized receipt for all such confiscated items. The court, when hearing the case concerning the alleged violation may, in addition to any other penalty imposed upon finding of guilt, order the forfeiture to the Department of all or part of the confiscated items.

The Zuni Indian Reservation is Tribal Land and is not open to unauthorized public use. All visitors are expected to abide by all Fish and Wildlife Department and other Tribal Regulations. Please see Section on Hiking for additional Rules and Regulations. This proclamation will remain in effect until a subsequent proclamation is approved.
